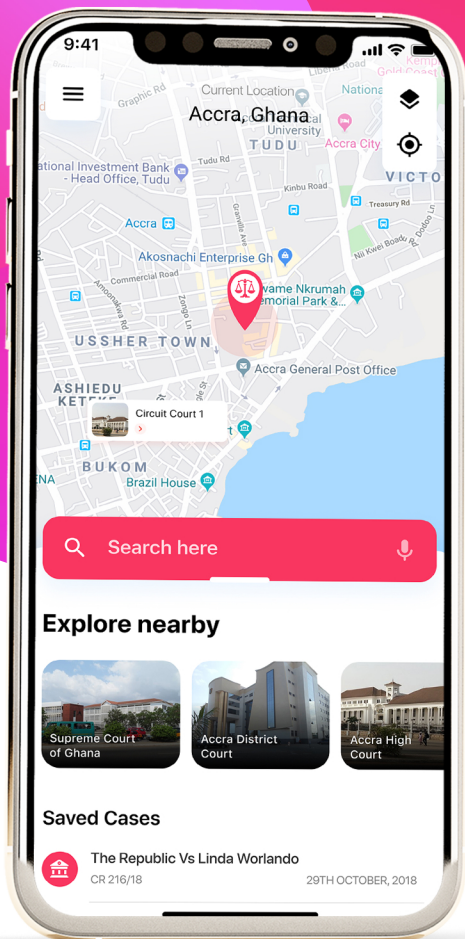

INTRODUCTION

Justice Locator is a mobile application designed to assist the ordinary Ghanaian access justice and help legal practitioners manage their court diaries with ease. Our focus in developing this mobile application is to transform the legal landscape with technology. The application will serve as a platform where Ghanaians can have information of the Agents of Justice namely, the names of courts, name(s) of the judge(s) of a court and official contact details of the registrars of the courts.

The Justice Locator App is also designed to help a user to easily navigate to a particular court whiles driving, using public transport or walking.

The Justice Locator App will be updated with the cause lists of all the courts in Ghana every week. This will enable legal practitioners to easily access this information on their mobile devices anywhere at any time. The Justice Locator App confirms justice as a service by assisting users to get directions to courts and providing the public with details in a court's diary.

A simple user interface has been created to help legal practitioners, judges and users of the court services manage their activities within the app by setting reminders on a particular case in a court if they do require.





WHAT PROBLEMS ARE THE JUSTICE LOCATOR APP SOLVING?

The 1992 Constitution of Ghana boldly asserts that **“Justice emanates from the people ...”** This implies that the people of Ghana are owners and beneficiaries of justice and the judiciary are only trustees who must uphold same in favour of the people. The main popular access to the justice mechanism in Ghana is the formal court system. Whilst it is true that the current justice system is doing very well in the face of several constraints, it is important to address some key challenges with the system especially with regards to access to justice. Some of the challenges to justice includes the following:

01

Legal Practitioners Struggle To Locate The Courts.

Finding your way to a court as a lawyer or an officer of the court must not be stressful. However, most people struggle to find the exact location of courts in a town especially the Lower courts.

Court Users or Litigants Struggle To Locate Courts.

Usually, clients struggle to also locate courts where their cases are being heard. They must either take directions from the lawyer to the court or meet the lawyer and go to the court together.

Legal Practitioners Struggle To Get Cause Lists of Courts.

Lawyers must be updated with the diary or activities of the court for the day. Easy access to the Cause Lists of various courts would enable lawyers to schedule their activities. Despite the importance of the cause list to legal practitioners, this list is only available on the notice boards of the courts and consequently one must walk to the court before they see same.

WHAT PROBLEMS ARE THE JUSTICE LOCATOR APP SOLVING?

Lack of Information on Agents of Justice.

The public is mostly not updated with the name or brief information of a court, the name of the judge(s) of a court and the official contact of the court.

The Manual Way of Managing Case Activities on a Cause List.

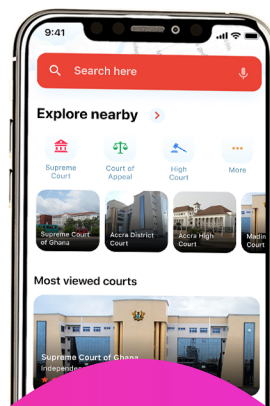

With a simple to use mobile app available on Android and iOS, we'll have you on board in no time!

1. Download the app from **Google Play** or **Apple Store**
2. Open Justice Locator and sign up
3. Select the court you want
4. The app uses your location to give you directions to your destination
5. Explore cause list of a court
6. Know the Judge(s) of the court
7. Get official contact information of the Registrars of the courts
8. Select a case from a court's cause list and bookmark your case activity
9. Set date reminders on your case activity

Get guidance on which lane you should be before your next move.



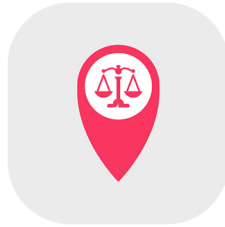
